



WAREHOUSE SERVICE AGREEMENT

Assumption of Liability/Liability Release

I, the undersigned, do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with visiting and working within an active warehouse environment. I fully understand that these risks can lead to severe injury and even loss of life. I understand that the warehouse activities include the movement and stacking of heavy loads and the use of forklifts and other warehouse equipment. Hazards may include, without limitation, collisions with equipment and falling objects.

Nevertheless, I choose to visit and work within the WorldTrans Services Inc. warehouse(s) for the benefit of my employer and/or myself, and I freely accept and expressly assume all risk, dangers and hazards that may arise from any and all warehouse activities. I further release WorldTrans Services Inc., its officers, directors, shareholders, employees and agents ("WorldTrans Services Inc. Parties") from all actions, causes of actions suits and any and all claims, demands and liabilities whatsoever, both in law and equity, which I may acquire against WorldTrans Services Inc. Parties in connection with any warehouse activity ("Claims"). I agree to indemnify and hold harmless WorldTrans Services Inc. Parties on account of any such Claims.

The terms hereof shall be binding upon my executors, heirs, administrator, and assigns.

In consideration of being allowed to visit and work within the WorldTrans Services Inc. warehouse(s) as well as the use of WorldTrans Services Inc. equipment and tools, I hereby agree:

- (a) To waive and release any and all claims based upon negligence, active or passive, with the exception of intentional, wanton or willful misconduct, that I may have in the future against WorldTrans Services Inc. Parties;
- (b) To release WorldTrans Services Inc. Parties for any claims or causes of action that I, my estate, heirs, executors or assigns may have for personal injury, property damage or wrongful death arising from warehouse activities whether caused by active or passive negligence or otherwise with the exception of gross negligence. I agree to hold the WorldTrans Services Inc. Parties harmless for any injury or loss of life which may occur to me as a result of warehouse activities.
- (c) By entering into this agreement I am not relying on any oral or written representation or statements made by the WorldTrans Services Inc. Parties other than what is set forth in this Agreement. I further agree that this Agreement shall be governed by and interpreted in accordance with California law.
- (d) If any provision of this release is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained in this Agreement.

I have read this Agreement, I understand it, and I agree to be bound by it.
